Nagarjun Municipality, Office of the Municipal Executive invites Electronic bids for works from eligible bidders for the construction as indicated in details of work below under **NCB-Single Stage Single Envelope Bidding** procedures as in accordance with e-GP Procurement Directive 2074. Eligible bidders should participate in this bidding and may obtain further information and inspect the Bidding Documents through PPMO website www.bolpatra.gov.np/egp.
