Bidding is open to all eligible Nepalese bidders.

- Minimum Work experience of similar size and nature:[One Contract of Covered Hall Construction project within the last ten (10) years, each with a value of at least **NRs 2,05,00,000.00 (Nrs. Two Crore Five Lakhs Only.) With VAT]**


