Invitation for Bids

Nagarjun Municipality, Office of the Municipal Executive has allocated funds towards the cost for construction as indicated in details of work below and intends to apply part of the funds to cover eligible payments under the contract for construction as indicated in details of work. Bidding is open to all eligible Nepalese bidders.

2. Nagarjun Municipality, Office of the Municipal Executive invites Electronic bids for S. N. 1&6 works from eligible bidders with the following key qualifications for the construction as indicated in details of work below under **NCB-Single Stage Two Envelope Bidding procedures and** Electronic bids for S. N. 2, 3,4,&5 works from eligible bidders for the construction as indicated in details of work below under **NCB-Single Stage Single Envelope Bidding** procedures as in accordance with e-GP Procurement Directive 2074. Eligible bidders should participate in this bidding and may obtain further information and inspect the Bidding Documents through PPMO website www.bolpatra.gov.np/egp.

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 5,85,00,000.00 (Five Crore Eighty-Five Lakhs only) With VAT.**
- Minimum Work experience of similar size and nature: **[One Contract of Road Pavement Construction project within the last ten (10) years, each with a value of at least NRs 3,15,00,000.00 (NRs. Three Crore Fifteen Lakhs Only) With VAT]**

Key qualifications for S. N. 6 works:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 3,80,00,000.00 (Three Crore Eighty Lakhs only) With VAT.**
- Minimum Work experience of similar size and nature: **[One Contract of Road Construction project within the last ten (10) years, each with a value of at least NRs 2,05,00,000.00 (NRs. Two Crore Five Lakhs Only) With VAT]**
